Ready-to-use disinfectant for the quick disinfection of dental impressions.



Intended Purpose



ASEPTOPRINT® Spray is a ready-to-use product for the rapid disinfection of dental impressions and impression trays. ASEPTOPRINT® Spray does not affect the dimensional stability of dental impressions made of alginate, polyether, polysulfide, A-silicone, and C-silicone.

Intended User



The product is intended for use by dental and healthcare professionals who have knowledge of the disinfection of medical devices. The product must not be used directly on patients.

Instructions for Use



For your protection, wear disposable gloves and safety goggles. Completely moisten the dental impression and impression tray and leave disinfectant to act. Adhere to, but do not exceed, the indicated contact time. After disinfection, rinse the dental impressions thoroughly under running water of at least drinking-water quality for 10 seconds. Use on alcohol-compatible materials only. A list of compatible and incompatible materials is available on our website. If you are unsure about the material composition of the medical device to be disinfected, contact the manufacturer before use. Any serious incident that has occurred in relation to the device should be reported to the manufacturer and the competent authority of the Member State in which the user and/or patient is established.

Limitation



FOR PROFESSIONAL USE ONLY. Do not mix with other products. Ensure that all visible soiling has been removed before disinfection. Failure to adhere to these limitations may reduce the efficacy of the product, thereby increasing the risk of infection.

Handling
