INSTRUCTIONS FOR USE

For your protection, wear disposable gloves and safety goggles. Completely moisten and wipe the entire surface of the medical device. Leave the disinfectant to act and adhere to contact time. Wipe medical devices that come into contact with skin using a water-soaked single-use cloth to prevent the build-up of biocides. Use on alcohol-compatible materials only. Before first use, check material compatibility on a small, inconspicuous area. A list of compatible and incompatible materials is available on our website. If you are unsure about the material composition of the medical device to be disinfected, contact the manufacturer before use. Any serious incident that has occurred in relation to the device should be reported to the manufacturer and the competent authority of the Member State in which the user and/or patient is established.
